Once you arrive at Camp Saginaw please park on the Left. Do not drive your car past the parking lot.

- 1 All volunteers must check in immediately upon arrival at the camp with the Camp Dreamcatcher Staff.
- 2 All volunteers must sign the required agreements/forms. All visitors will receive a name badge, and must wear this name badge while on camp premises.
- 3 Unless otherwise directed by the camp director or program director, all volunteers must be accompanied by a camp staff person at all times during their visit.
- 4 If it is necessary for a visitor to spend the night on camp premises, advance notice must be given to the camp director and a criminal background check must be performed. No volunteer may stay overnight unless the background check is completed and permission obtained from the camp director
- 5 No volunteer may spend the night on camp premises unless they have read, signed and agreed to abide by the Camp Rules and Camp Dreamcatcher Agreements, noted above.
- 6 Any volunteers or guest found not to be in compliance with the above requirements will be asked to immediately vacate the premises and will be escorted by a camp staff member from the premises. They will be informed that should they return to the premises without complying with the requirements, they will be considered to be trespassers and appropriate action taken by the camp.
